BACKGROUND

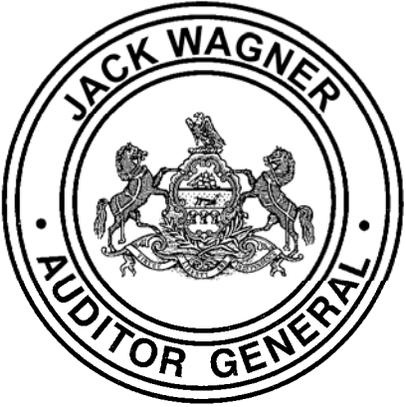
On December 18, 1984, the Pennsylvania Legislature adopted the Municipal Pension Plan Funding Standard and Recovery Act (P.L. 1005, No. 205, as amended, 53 P.S. § 895.101 et seq.). The act established mandatory actuarial reporting and funding requirements and a uniform basis for the distribution of state aid to Pennsylvania's public pension plans. Section 402(j) of Act 205 specifically requires the Auditor General, as deemed necessary, to make an audit of every municipality which receives general municipal pension system State aid and of every municipal pension plan and fund in which general municipal pension system State aid is deposited.

Pension plan aid is provided from a 2 percent foreign casualty insurance premium tax, a portion of the foreign fire insurance tax designated for paid firefighters and any investment income earned on the collection of these taxes. Generally, municipal pension plans established prior to December 18, 1984, are eligible for state aid. For municipal pension plans established after that date, the sponsoring municipality must fund the plan for three plan years before it becomes eligible for state aid. In accordance with Act 205, a municipality's annual state aid allocation cannot exceed its actual pension costs.

In addition to Act 205, the Bedford Borough Police Pension Plan is also governed by implementing regulations adopted by the Public Employee Retirement Commission published at Title 16, Part IV of the Pennsylvania Code and applicable provisions of various other state statutes including, but not limited to, the following:

Act 600 - Police Pension Fund Act, Act of May 29, 1956 (P.L. 1804, No. 600), as amended, 53 P.S. § 761 et seq.

The Bedford Borough Police Pension Plan is a single-employer defined benefit pension plan locally controlled by the provisions of Chapter 1, Section 6 of the Borough of Bedford's codified ordinances, adopted pursuant to Act 600. The plan is also affected by the provisions of collective bargaining agreements between the borough and its police officers.

We have conducted a compliance audit of the Bedford Borough Police Pension Plan for the period January 1, 2006, to December 31, 2008. The audit was conducted pursuant to authority derived from Section 402(j) of Act 205 and in accordance with *Government Auditing Standards* applicable to performance audits issued by the Comptroller General of the United States. Those standards require that we plan and perform our audit to obtain sufficient, appropriate evidence to provide a reasonable basis for our finding and conclusions based on our audit objectives. We believe that the evidence obtained provides a reasonable basis for our finding and conclusions based on our audit objectives.

The objectives of the audit were:

1. To determine if municipal officials took appropriate corrective action to address the finding contained in our prior audit report; and
2. To determine if the pension plan was administered in compliance with applicable state laws, regulations, contracts, administrative procedures, and local ordinances and policies.

Our audit was limited to the areas related to the objectives identified above.

Borough officials are responsible for establishing and maintaining effective internal controls to provide reasonable assurance that the Bedford Borough Police Pension Plan is administered in compliance with applicable state laws, regulations, contracts, administrative procedures, and local ordinances and policies. In conducting our audit, we obtained an understanding of the borough's internal controls as they relate to the borough's compliance with those requirements and that we considered to be significant within the context of our audit objectives, and assessed whether those significant controls were properly designed and implemented. Additionally, we tested transactions, assessed official actions, performed analytical procedures and interviewed selected officials to the extent necessary to satisfy the audit objectives.

The results of our tests indicated that, in all significant respects, the Bedford Borough Police Pension Plan was administered in compliance with applicable state laws, regulations, contracts, administrative procedures, and local ordinances and policies, except as noted in the following finding further discussed later in this report:

The accompanying supplementary information is presented for purposes of additional analysis. We did not audit the information and, accordingly, express no form of assurance on it.

The contents of this report were discussed with officials of Bedford Borough and, where appropriate, their responses have been included in the report.

STATUS OF PRIOR FINDING

Noncompliance With Prior Audit Recommendation

Bedford Borough has not complied with the prior audit recommendation concerning the following as further discussed in the Finding and Recommendation section of this report:

- Inconsistent Pension Benefit Provisions

FINDING AND RECOMMENDATION

Finding – Noncompliance With Prior Audit Recommendation – Inconsistent Pension Benefit Provisions

Condition: As disclosed in the prior audit report, the borough adopted the benefit changes in accordance with Act 600, as amended by Act 30, through the collective bargaining agreement between the borough and its police officers for the period January 1, 2003, to December 31, 2005. These benefit changes are also contained in the collective bargaining agreement for the period January 1, 2006, to December 31, 2008. However, the pension plan’s governing document still has not been amended to reflect the following revised benefit provisions incorporated into the collective bargaining agreements:

<u>Benefit Provision</u>	<u>Governing Document</u>	<u>Collective Bargaining Agreement</u>
Killed in service benefit	The surviving spouse, to whom he/she was continuously married throughout the 1 year period ending on the date he/she dies shall, during his or her lifetime or so long as he or she does not remarry, be entitled to receive a pension calculated at a rate of 50% of the pension the member would have been receiving had he or she been retired at the time of death, off-set by any workmen’s compensation received.	One hundred percent (100%) of the member’s salary at the time of death.

<u>Benefit Provision</u>	<u>Governing Document</u>	<u>Collective Bargaining Agreement</u>
Survivor's benefit	Not provided	Fifty (50%) percent of the pension the member was receiving or eligible to receive if retired at time of death. Upon death of the spouse, or if no spouse survives, the benefits shall be paid to the child or children under the age of eighteen (18) years, or if attending college, under or attaining the age of twenty-three (23) years.
Service-related disability benefit	Monthly disability pension equal to 50% of the average monthly compensation of member during 36 months prior to date of disability, offset by any benefits from workmen's compensation insurance.	Fifty percent (50%) of the member's salary at the time the disability was incurred, less any benefits provided under the Social Security Act.
Pre-vesting death benefit	Member's beneficiary entitled to a refund of member's contributions, plus interest earned on such moneys while in the police pension fund.	The surviving spouse of a member, or if no surviving spouse survives, the child or children under the age of eighteen (18) years or if attending college, under the age of twenty-three (23) years, shall receive payment of all the member's contributions to the plan plus interest unless the member has designated another beneficiary.

Accumulated paid leave to be included in the pension benefit determination	The pay as reported on Form W-2, including salary, court pay, holiday pay and any other remuneration.	Accumulated paid leave earned during the measuring period for calculating a member's benefit, the last thirty-six (36) months of employment.

Criteria: A governing document which contains clearly defined and updated benefit provisions is a prerequisite for the consistent, sound administration of retirement benefits. The pension plan's benefit structure should be consistent with the collective bargaining agreement and in compliance with the provisions of Act 600, as amended.

Cause: Municipal officials failed to establish adequate internal control procedures to ensure the plan's governing document was updated to reflect the benefit provisions contained in the collective bargaining agreements.

Effect: Inconsistent plan documents could result in inconsistent or improper benefit calculations and incorrect benefit payments from the pension plan.

Recommendation: We again recommend that municipal officials, after consulting with their solicitor, amend the plan's governing document to reflect the updated benefit provisions contained in the collective bargaining agreements.

Management's Response: Municipal officials agreed with the finding without exception.

SCHEDULE OF FUNDING PROGRESS

Historical trend information about the plan is presented herewith as supplementary information. It is intended to help users assess the plan's funding status on a going-concern basis, assess progress made in accumulating assets to pay benefits when due, and make comparisons with other state and local government retirement systems.

The actuarial information is required by Act 205 biennially, except for distressed pension plans, for which annual reporting was required through January 1, 2003. The historical information, beginning as of January 1, 2003, is as follows:

The comparability of trend information is affected by changes in actuarial assumptions, benefit provisions, actuarial funding methods, accounting policies, and other changes. Those changes usually affect trends in contribution requirements and in ratios that use the actuarial accrued liability as a factor.

Analysis of the dollar amount of the actuarial value of assets, actuarial accrued liability, and unfunded (assets in excess of) actuarial accrued liability in isolation can be misleading. Expressing the actuarial value of assets as a percentage of the actuarial accrued liability (Column 4) provides one indication of the plan's funding status on a going-concern basis. Analysis of this percentage, over time, indicates whether the system is becoming financially stronger or weaker. Generally, the greater this percentage, the stronger the plan.

Trends in unfunded (assets in excess of) actuarial accrued liability and annual covered payroll are both affected by inflation. Expressing the unfunded (assets in excess of) actuarial accrued liability as a percentage of annual covered payroll (Column 6) approximately adjusts for the effects of inflation and aids analysis of the plan's progress made in accumulating sufficient assets to pay benefits when due. Generally, where there is an unfunded actuarial accrued liability, the smaller this percentage, the stronger the plan. However, when assets are in excess of the actuarial accrued liability, the higher the bracketed percentage, the stronger the plan.
