Dear Dr. Stropkaj and Mr. Cesario:

We conducted a Limited Procedures Engagement (LPE) of the Keystone Oaks School District (District) to determine its compliance with certain relevant state laws, regulations, policies, and administrative procedures (relevant requirements). The LPE covers the period July 1, 2012, through June 30, 2015, except for any areas of compliance that may have required an alternative to this period. The engagement was conducted pursuant to authority derived from Article VIII, Section 10 of the Constitution of the Commonwealth of Pennsylvania and the Fiscal Code, 72 P.S. §§ 402 and 403, but was not conducted in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States.

As we conducted our LPE procedures, we sought to determine answers to the following questions, which serve as our LPE objectives:

- Did the District have documented board policies and administrative procedures related to the following?
  - Internal controls
  - o Budgeting practices
  - The Right-to-Know Law
  - The Sunshine Act
- Were the policies and procedures adequate and appropriate, and have they been properly implemented?
- Did the District comply with the relevant requirements in the Right-to-Know Law and the Sunshine Act?
- Did the District take appropriate corrective action to address the observation made in our prior audit, and were the actions taken into effect?

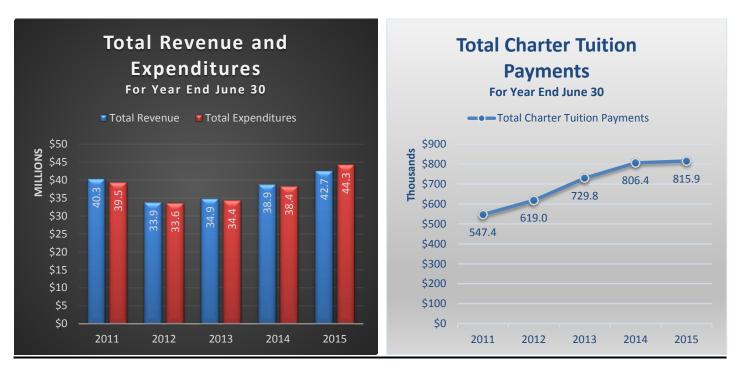

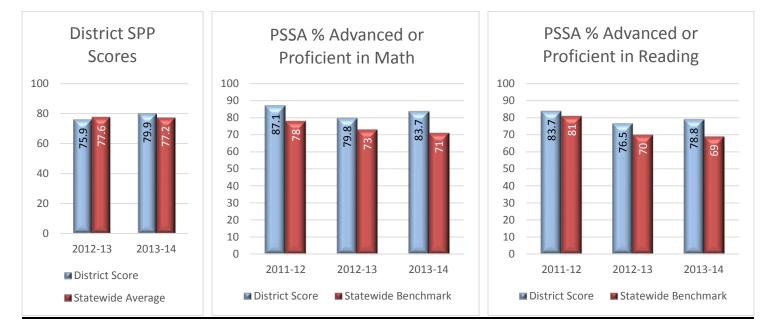


## **Academic Information**

The following table and charts consist of School Performance Profile (SPP) scores and Pennsylvania System of School Assessment (PSSA) results for the entire District obtained from PDE's data files.<sup>1</sup> These scores are presented in the District's audit report for **informational purposes only**, and they were not audited by our Department.

SPP benchmarks represent the statewide average of all district school buildings in the Commonwealth.<sup>2</sup> PSSA benchmarks and goals are determined by PDE each school year and apply to all public school entities.<sup>3</sup> District SPP and PSSA scores were calculated using an average of all of the individual school buildings within the District. Scores below SPP statewide averages and PSSA benchmarks/goals are presented in red.

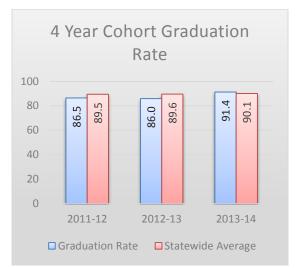
#### Individual School Building SPP and PSSA Scores

#### **4 Year Cohort Graduation Rates**

The cohort graduation rates are a calculation of the percentage of students who have graduated with a regular high school diploma within a designated number of years since the student first entered high school. The rate is determined for a cohort of students who have all entered high school for the first time during the same school year.<sup>6</sup>

## **Status of Prior Audit Findings and Observations**

Our prior audit of the District released on August 2, 2013, resulted in one observation, as shown below. As part of our current engagement, we determined the status of corrective action taken by the District to implement our prior audit recommendations. We interviewed District personnel, and performed audit procedures as detailed in each status section below.

#### Auditor General Performance Audit Report Released on August 2, 2013

Prior Observation	The District Lacks Sufficient Internal Controls Over Its Student Data
Prior Observation Condition	During our prior audit of the Keystone Oaks School District's (District) controls over data integrity, we found that internal controls needed to be improved. Our review specifically found that:
	The District does not maintain adequate evidence of manual compensating controls related to documentation supporting its student registrations.
	The District did not have documentation of residence for the natural parents of one nonresident foster student. The student attended classes at the District for 24 days.
	The District did not completely upload the registration for one student who was registered in the District for a period of time, then withdrew, and then subsequently re-registered with the District. In this instance, the District failed to upload the student's second registration into PIMS.
	The District's calendar reports did not reconcile. For example, two summary reports from the District's Student Information System (SIS) listed the days in session for Dormont Elementary School as 182. However, the other two reports, the Child Accounting Vendor Data Base report and the PIMS Student Calendar Fact Template, listed the days in session for that school as 180.
	Keystone Oaks Middle School and Dormont Elementary School do not maintain permanent record folders for students that transfer to another school district within the state of Pennsylvania.
	The District does not have adequate documented procedures in place to ensure continuity over its PIMS data submission in the event of a sudden change in personnel or child accounting vendors.

Prior Recommendations	The Keystone Oaks School District should:				
	<ol> <li>Maintain adequate evidence of manual compensating controls (i.e. supporting documentation) to support its student registration.</li> </ol>				
	2. Develop documented procedures (e.g. procedures manual, policies or other written instructions) to ensure continuity over PIMS data submission if those involved persons were to leave the District suddenly or otherwise be unable to upload PIMS to PDE.				
	3. Review membership reports submitted to PDE for years subsequent to the audit, and if similar errors are found, submit reviewed reports to PDE.				
Current Status	During our current review, we have found that the District did implement our prior recommendations. The District has modified it student registration policies to ensure that each step of the student registration process is documented.				
	The District now keeps a backup PIMS person trained and ready to step in if the PIMS Director becomes unavailable.				
	The Superintended has supplied written confirmation that the District reviewed the membership reports for the years subsequent to the prior audit, and no similar problems were found.
