Dear Dr. Costello and Mr. Kleinfelter:

We conducted a Limited Procedures Engagement (LPE) of the Owen J. Roberts School District (District) to determine its compliance with certain relevant state laws, regulations, policies, and administrative procedures (relevant requirements). The LPE covers the period July 1, 2012, through June 30, 2016, except for any areas of compliance that may have required an alternative to this period. The engagement was conducted pursuant to authority derived from Article VIII, Section 10 of the Constitution of the Commonwealth of Pennsylvania and The Fiscal Code (72 P.S. §§ 402 and 403), but was not conducted in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States.

As we conducted our LPE procedures, we sought to determine answers to the following questions, which serve as our LPE objectives:

- Did the District have documented board policies and administrative procedures related to the following?
  - Internal controls
  - o Budgeting practices
  - The Right-to-Know Law
  - The Sunshine Act
- Were the policies and procedures adequate and appropriate, and have they been properly implemented?
- Did the District comply with the relevant requirements in the Right-to-Know Law and the Sunshine Act?
- Did the District take appropriate corrective action to address the finding made in our prior audit?






## **Academic Information**

The following table and charts consist of School Performance Profile (SPP) scores and Pennsylvania System of School Assessment (PSSA) results for the entire District obtained from PDE's data files.<sup>1</sup> These scores are presented in the District's audit report for **informational purposes only**, and they were not audited by our Department.

SPP benchmarks represent the statewide average of all district school buildings in the Commonwealth.<sup>2</sup> PSSA benchmarks and goals are determined by PDE each school year and apply to all public school entities.<sup>3</sup> District SPP and PSSA scores were calculated using an average of all of the individual school buildings within the District. Scores below SPP statewide averages and PSSA benchmarks/goals are presented in red.



## **4 Year Cohort Graduation Rates**

The cohort graduation rates are a calculation of the percentage of students who have graduated with a regular high school diploma within a designated number of years since the student first entered high school. The rate is determined for a cohort of students who have all entered high school for the first time during the same school year.<sup>6</sup>

# **Status of Prior Audit Findings and Observations**

Our prior audit of the District released on June 19, 2014, resulted in one finding as shown below. As part of our current engagement, we determined the status of corrective action taken by the District to implement our prior audit recommendations. We reviewed the District's written response provided to PDE, interviewed District personnel, and performed audit procedures as detailed in each status section below.

Prior Finding:	Certification Deficiency				
Prior Finding Summary:	During our prior audit of the District, we found that one employee wa assigned as the District's Instructional Technology Coordinator since August 11, 2009, without possessing an Instructional Technology Specialist Certificate. The District was, therefore, subject to a subside forfeiture of \$8,841.				
Prior Recommendations:	We recommended that the District should:				
	1. Implement internal controls to ensure that employee assignments are compared with approved position description duties and PDE's Certification and Staffing Policy Guidelines to ensure that all employees possess the appropriate certification for their assigned positions.				
	2. Assign an appropriately certified individual to the Instructional Technology Coordinator position.				
	We also recommended that PDE should:				
	3. Adjust the District's allocations to recover the subsidy forfeiture.				
Current Status:	We found that the District and PDE implemented our prior audit recommendations. The employee cited in our prior audit finding obtained the proper certification on July 1, 2014. PDE adjusted the District's allocations to recover the subsidy forfeiture in December 2014.
