Dear Dr. Thomas and Mr. Lytle:

We conducted a Limited Procedures Engagement (LPE) of the York County School of Technology (School of Technology) to determine its compliance with certain relevant state laws, regulations, policies, and administrative procedures (relevant requirements). The LPE covers the period July 1, 2012, through June 30, 2016, except for any areas of compliance that may have required an alternative to this period. The engagement was conducted pursuant to authority derived from Article VIII, Section 10 of the Constitution of the Commonwealth of Pennsylvania and The Fiscal Code (72 P.S. §§ 402 and 403), but was not conducted in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States.

As we conducted our LPE procedures, we sought to determine answers to the following questions, which serve as our LPE objectives:

- Did the School of Technology have documented board policies and administrative procedures related to the following?
 - Internal controls
 - o Budgeting practices
 - o The Right-to-Know Law
 - The Sunshine Act
- Were the policies and procedures adequate and appropriate, and have they been properly implemented?
- Did the School of Technology comply with the relevant requirements in the Right-to-Know Law and the Sunshine Act?
- Did the School of Technology take appropriate corrective action to address the findings, made in our prior audit?


The operation, administration, and management of the School of Technology are directed by a joint operating committee (JOC), which is comprised of 14 members from the following school districts:










Note: General Fund Balance is comprised of the District's Committed, Assigned and Unassigned Fund Balances.



Local revenues were primarily obtained from direct payments by the member districts based on the approved budget. Each district's proportionate share of the operating expenditures was determined by a formula involving average daily membership as specified in the Articles of Agreement.

Academic Information

The following table and charts consist of School Performance Profile (SPP) scores and Pennsylvania System of School Assessment (PSSA) results for the entire School of Technology obtained from PDE's data files. These scores are presented in the School of Technology's audit report for **informational purposes only**, and they were not audited by our Department.

SPP benchmarks represent the statewide average of all district school buildings in the Commonwealth.² PSSA benchmarks and goals are determined by PDE each school year and apply to all public school entities.³




² Statewide averages for SPP scores were calculated based on all district school buildings throughout the Commonwealth, excluding charter and cyber charter schools.










4 Year Cohort Graduation Rates

The cohort graduation rates are a calculation of the percentage of students who have graduated with a regular high school diploma within a designated number of years since the student first entered high school. The rate is determined for a cohort of students who have all entered high school for the first time during the same school year.⁵

Status of Prior Audit Findings and Observations

Our prior audit of the School of Technology released on December 22, 2011, resulted in two findings, as shown below. As part of our current engagement, we determined the status of corrective action taken by the School of Technology to implement our prior audit recommendations. We interviewed School of Technology personnel and performed audit procedures as detailed in each status section below.

Auditor General Performance Audit Report Released on December 22, 2011

Prior Finding No. 1: Failure to Have All School Bus Drivers' Qualifications on File

Prior Finding Summary: Our prior audit of the School of Technology's personnel records found

that two bus drivers for the 2010-11 school year did not have the federal criminal history record information (known as FBI clearances)

required by Public School Code (PSC) Section 111 on file.

<u>Prior Recommendations:</u> We recommended that the School of Technology should:

Develop a system that can track the status of all current bus drivers' qualification records. This will ensure that all bus drivers transporting pupils are properly qualified for their position and that the school is in

compliance with the PSC.

Current Status: We found the School of Technology did implement our prior

recommendation. The District obtained the FBI clearances for the two bus drivers cited in the prior finding. Both FBI clearances did not

reveal any issues that would preclude the bus drivers from

employment. The District developed a system that will track the status of all current bus drivers' qualification records. This will help to ensure that all bus drivers are properly qualified. Our review of the District's current bus drivers' personnel records did not reveal any

issues.

Prior Finding No. 2: Certification Deficiency

Prior Finding Summary: Our prior audit of the School of Technology found one individual was

teaching physics for the first semester of the 2010-11 school year without appropriate certification. Therefore, the School of Technology

was subject to a subsidy forfeiture of \$347.

<u>Prior Recommendations:</u> We recommended that the School of Technology should:

- 1. Take the necessary action required to ensure compliance with certification requirements.
- 2. Ensure only properly certified individuals holding current and valid certificates are allowed to teach students.

We also recommended that PDE should:

3. Adjust the School of Technology's allocation to recover the \$347 subsidy forfeiture.

Current Status:

We found the School of Technology did implement our prior recommendations. The District obtained an emergency certification for the physics teacher cited in the prior finding prior to the 2011-12 school year. As of March 23, 2017, PDE has not adjusted the School of Technology's subsidy to resolve the \$347 forfeiture that was identified during our prior audit.
