The Pennsylvania Department of the Auditor General conducted an audit of Harmony Area School District for the period July 1, 2014 to June 30, 2018 and provided one finding. The finding stated that: The District inaccurately reported transportation costs resulting in an underpayment of \$11,422. The school administration concurred with the finding and provided the following response: Internal controls due primarily to staff turnover were not sufficient to discover the errors in transportation reporting. The requirements for pupil transportation will be reviewed and district processes updated. The Business Manager will review reports prior to submission.
