TOWNSHIP OF DRUMORE LANCASTER COUNTY LIQUID FUELS TAX FUND BACKGROUND FOR THE YEAR ENDED DECEMBER 31, 2008

Background

The Liquid Fuels Tax Municipal Allocation Law, Title 72 P.S. § 2615.5, provides municipalities other than counties (townships, boroughs, cities, towns, home rule, and optional plan governments) with an annual allocation of liquid fuels taxes from the state's Motor License Fund to be used for the maintenance and repair of streets, roads, and bridges for which the municipality is responsible. The allocation of these funds to municipalities is based: (1) 50 percent on the municipality's proportion of local road mileage to the total local road mileage in the state, and (2) 50 percent on the proportion of a municipality's population to the total population in the state.

The Vehicle Code, Title 75 P.S. § 9511, provides municipalities with annual maintenance payments to be received from the Motor License Fund for functionally local highways that were transferred to a municipality from the Commonwealth of Pennsylvania.

Each municipality must deposit the Liquid Fuels Tax Fund money and annual maintenance payments that it receives into a special fund called the Municipal Liquid Fuels Tax Fund or State Fund. A municipality may not deposit any other monies into this fund except when the municipality does not have enough money in the special fund to meet the payments called for by its current annual budget for road and bridge purposes. In this case, the municipality may borrow money or transfer money from its General Fund to its Liquid Fuels Tax Fund.

The Department of Transportation has been given the regulatory authority for the administration of these funds. To qualify for its annual allocation, each municipality shall submit the following documents and information to the Department of Transportation:

- 1. Evidence that the treasurer is bonded in accordance with the law, or that its treasurer is a bank requiring no bond by January 31 of each year.
- 2. A report indicating the manner in which its liquid fuels tax allocation was expended in the previous year (Form MS-965) by January 31 of each year.
- 3. A report of elected and appointed officials by January 31 of each year.
- 4. A Survey of Financial Condition by March 15 of each year.

Department of Transportation *Publication 9* contains the policies and procedures that govern the use of Liquid Fuels Tax Fund money. However, if there is a difference between *Publication 9* and any legislation, the legislation shall govern.



Independent Auditor's Report

We examined the accompanying Forms MS-965 With Adjustments for the Liquid Fuels Tax Fund of the Township of Drumore, Lancaster County, for the year ended December 31, 2008. The municipality's management is responsible for the Forms MS-965. Our responsibility is to express an opinion on the Forms MS-965 With Adjustments based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements contained in *Government Auditing Standards* issued by the Comptroller General of the United States. An examination includes examining, on a test basis, evidence supporting the Township of Drumore, Lancaster County's Forms MS-965 for the year ended December 31, 2008 and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

We are mandated by Section 403 of *The Fiscal Code*, 72 P.S. § 403, to audit each municipality's Liquid Fuels Tax Fund to ensure that funds received are expended in accordance with applicable laws and regulations. *Government Auditing Standards* issued by the Comptroller General of the United States include attestation engagements as a separate type of audit. An attestation engagement performed pursuant to *Government Auditing Standards* involves additional standards that exceed the standards provided by the American Institute of Certified Public Accountants. Accordingly, this attestation engagement complies with both *Government Auditing Standards* and Section 403 of *The Fiscal Code*.

As described in Note 4, the adjustments included on the Forms MS-965 With Adjustments are made by the Department of the Auditor General.

Independent Auditor's Report (Continued)

As discussed in Comment No. 1 of this report, during our 2000-2002 audit, we recommended that the municipality reimburse \$779,844.12 to its Liquid Fuels Tax Fund. This amount consists of \$507,262.24 for questionable costs from the Liquid Fuels Tax Fund and \$272,581.88 for questionable costs from its Highway Transfer Program-Turnback Account. On November 20, 2006, the municipality and the Department of Transportation reached an agreement for the municipality to reimburse \$196,141.13 to its Liquid Fuels Tax Fund over a period of four years. During our prior examination, the township reimbursed \$50,000.00. During our current examination the township reimbursed \$50,000.00 to its Liquid Fuels Tax Fund leaving a balance due of \$96,141.13.

As discussed in Comment No. 2 of this report, during our 2003-2005 audit, we recommended that the municipality reimburse \$255,032.20 to its Liquid Fuels Tax Fund. This amount consists of \$230,406.85 for questionable costs, \$19,431.72 for the failure to maintain documentation for price quotations, \$3,793.63 for the failure to maintain documentation supporting payroll expenditures, and \$1,400.00 for a nonpermissible expenditure. As of November 10, 2009, the date of this report, the Department of Transportation had not determined if the reimbursement of \$255,032.20 would be required.

In our opinion, except for the matters discussed in the two preceding paragraphs, the Forms MS-965 With Adjustments present, in all material respects, the information required by the Pennsylvania Department of Transportation for the Liquid Fuels Tax Fund of the Township of Drumore, Lancaster County, for the year ended December 31, 2008, in conformity with the criteria set forth in Note 1.

In accordance with *Government Auditing Standards*, we are required to report findings of significant deficiencies in internal control, violations of provisions of contracts or grant agreements, and abuse that are material to the Forms MS-965 and any fraud and illegal acts that are more than inconsequential that come to our attention during our examination. We are also required to obtain the views of management on those matters. We performed our examination to express an opinion on whether the Forms MS-965 are presented in accordance with the criteria described above and not for the purpose of expressing an opinion on the internal control over reporting on the Forms MS-965 or on compliance and other matters; accordingly, we express no such opinions.

<u>Independent Auditor's Report (Continued)</u>

A control deficiency exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect misstatements on a timely basis. A significant deficiency is a control deficiency, or combination of control deficiencies, that adversely affects the Township of Drumore, Lancaster County's ability to initiate, authorize, record, process, or report data reliably in accordance with the applicable criteria such that there is more than a remote likelihood that a misstatement of the Township of Drumore, Lancaster County's Forms MS-965 that is more than inconsequential will not be prevented or detected by the Township of Drumore, Lancaster County's internal control.

A material weakness is a significant deficiency or combination of significant deficiencies that results in more than a remote likelihood that a material misstatement of the Forms MS-965 will not be prevented or detected by the Township of Drumore, Lancaster County's internal control.

Our consideration of internal control over reporting on the Forms MS-965 was for the limited purpose described in the first paragraph of this section and would not necessarily identify all deficiencies in internal control that might be significant deficiencies or material weaknesses. We did not identify any significant deficiencies or material weaknesses, as defined above, in internal control over reporting on the Forms MS-965.

The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*.

This report is intended solely for the information and use of the Pennsylvania Department of Transportation and the management of the Township of Drumore, Lancaster County, and is not intended to be and should not be used by anyone other than these specified parties.

1. Criteria

Section 1

This section of Form MS-965 With Adjustments provides a summary of Liquid Fuels Tax Fund expenditures by category. Categories requiring explanation include:

- Major equipment purchases are purchases of road machinery and road equipment that cost in excess of \$4,000.00.
- Minor equipment purchases are purchases of road machinery and road equipment that cost \$4,000.00 or less.
- Agility projects are exchanges of services with the Department of Transportation.

Section 2

This section of Form MS-965 With Adjustments provides information on the fund balance. Categories requiring explanation include:

- The state allocation is generally received from the Department of Transportation during the first week in April of each year. The amount the municipality receives is based half on its population and half on its road mileage.
- The turnback allocation is generally received from the Department of Transportation during the first week in April of each year. A municipality receives a yearly turnback allocation based on road mileage for all roads that were transferred to the municipality from the Commonwealth of Pennsylvania through the Highway Transfer Program.
- Expenditures include the total transferred from Section 1.

Section 3

This section of Form MS-965 With Adjustments determines if the municipality expended Liquid Fuels Tax Fund money in excess of the permissible amount for equipment and the balance that the municipality may carry forward for the purchase of equipment to the subsequent year.

1. <u>Criteria (Continued)</u>

Section 3 (Continued)

Department of Transportation *Publication 9* requires that the amount expended for equipment purchases in a given year not exceed the sum of the equipment balance carried forward from the previous year and 20 percent of the current year's Liquid Fuels Tax Fund allocation and, if applicable, 20 percent of the turnback allocation plus other Department of Transportation approved adjustments.

If the municipality spent in excess of the amount listed on Line 4, the excess must be reimbursed to the Liquid Fuels Tax Fund.

The equipment balance to be carried forward for the subsequent year is the lesser of the amount on Line 6 or the ending fund balance on Line 6 of Section 2, but not less than zero.

Basis Of Presentation

The financial activities of the municipality are accounted for in separate funds. The Liquid Fuels Tax Fund is used to account for state aid revenues from the Pennsylvania Department of Transportation used primarily for building and improving local roads and bridges. The Form MS-965 has been prepared in accordance with reporting requirements prescribed by the Pennsylvania Department of Transportation as a result of the Fuels Tax Act 655, dated 1956 and as amended, which does not constitute a complete presentation of the entity's assets, liabilities, expenses, and fund balance. Accordingly, the presentation of Form MS-965 With Adjustments is restricted to the Liquid Fuels Tax Fund, which represents a segment of the entity.

Basis Of Accounting

The accompanying Form MS-965 With Adjustments is prepared in accordance with reporting requirements prescribed by the Pennsylvania Department of Transportation. Under this method, revenues are recognized when received and expenditures are recorded when paid.

1. Criteria (Continued)

General Fixed Assets

General fixed assets are recognized as expenditures at the time of purchase. No depreciation has been provided on the heavy equipment used to maintain and repair roads and bridges.

2. Deposits

The Second Class Township Code, Title 53 P.S. § 68204, authorizes the township to deposit its funds in the following:

- Deposits in savings accounts or time deposits, other than certificates of deposit or share accounts of institutions having their principal place of business in the Commonwealth of Pennsylvania and insured by the Federal Deposit Insurance Corporation (FDIC) or other like insurance. For any amount above the insured maximum, the depository shall pledge approved collateral.
- Certificates of deposit purchased from institutions insured by the FDIC or other like insurance to the extent that such accounts are so insured. For any amounts in excess of the insured maximum, such deposits shall be collateralized by a pledge or assignment of assets. Certificates of deposit may not exceed 20 percent of a bank's total capital surplus or 20 percent of a savings and loan's or savings bank's assets minus liabilities.

Deposits consist of receipts and deposits in a financial institution. Pennsylvania statutes require all deposits to be insured and, for any amount above the insured maximum, to be secured with approved collateral as defined.

There were no deposits exposed to custodial credit risk as of December 31, 2008. Custodial credit risk, as defined by GASB No. 40, includes deposits that are not covered by depository insurance and the deposits are uncollateralized, collateralized with securities held by the pledging financial institution, or collateralized with securities held by the pledging financial institution's trust department or agent but not in the municipality's name.

3. <u>Interest On Investments</u>

Our examination disclosed that the municipality deposited idle liquid fuels tax money in an interest-bearing account which earned \$2,422.03 during 2008, thus providing additional funds for road maintenance and repairs.

4. Adjustments

Section 1

An adjustment of \$(564.10) was made to "Miscellaneous" expenditures because bank service charges were overstated.

Section 2

An adjustment of \$(564.10) was made to "Balance, January 1, 2008" because of prior report adjustments that were not carried forward in the fund balance.

5. Lease-Purchase Agreement

On September 26, 2005, the municipality purchased a new Caterpillar 938G wheel loader for \$127,250.00. The municipality received a trade-in allowance of \$65,000.00 and made a down payment of \$20,000.00 from the Liquid Fuels Tax Fund, leaving an amount to be financed of \$42,250.00. Additionally, the outstanding balance of the lease-purchase agreement for the wheel loader that was traded-in was \$67,339.90. The municipality entered into a lease-purchase agreement with M&T Bank for \$109,589.90 to pay the remaining \$42,250.00 for the new wheel loader and to pay off the balance of \$67,339.90 owed on the wheel loader that was traded-in. The agreement was for a term of 5 years at an interest rate of 5.43 percent. Annual principal and interest payments consist of one payment of \$18,000.00, three payments of \$25,000.00, and a final payment of \$27,650.52. Prior years' principal and interest payments from the Liquid Fuels Tax Fund were \$61,001.82 and 6,998.18, respectively.

During the current examination period the municipality paid principal of \$22,361.67 and interest of \$2,638.33 from the Liquid Fuels Tax Fund. These amounts are reflected in major equipment purchases on the 2008 Form MS-965 - Section 1. The outstanding balance of the lease-purchase agreement as of December 31, 2008 was \$26,226.41, plus interest.

TOWNSHIP OF DRUMORE LANCASTER COUNTY LIQUID FUELS TAX FUND COMMENTS FOR THE YEAR ENDED DECEMBER 31, 2008

Comment No. 1 - Summary of 2000-2002 Audit Recommendations

During our 2000-2002 audit, we recommended that the municipality reimburse \$779,844.12 to its Liquid Fuels Tax Fund. This amount consists of \$507,262.24 for questionable costs from the Liquid Fuels Tax Fund and \$272,581.88 for questionable costs from its Highway Transfer Program-Turnback Account. On November 20, 2006, the municipality and the Department of Transportation reached an agreement for the municipality to reimburse \$196,141.13 to its Liquid Fuels Tax Fund over a period of four years. Annual payments of \$50,000.00 are due the Liquid Fuels Tax Fund for the first three years beginning in 2007 with a final payment of \$46,141.13 due in 2010.

During our 2003-2005 examination period, the township reimbursed \$50,000.00 to its Liquid Fuels Tax Fund. During our current examination period the township reimbursed \$50,000.00 to its Liquid Fuels Tax Fund leaving a balance due of \$96,141.13 as of December 31, 2008.

Comment No. 2 - Summary of 2003-2005 Examination Recommendations

In our 2003-2005 audit we recommended that the Department of Transportation review our examination findings to determine if the municipality should reimburse \$255,032.20 to its Liquid Fuels Tax Fund. This amount consists of \$230,406.85 for questionable costs, \$19,431.72 for the failure to maintain documentation for price quotations, \$3,793.63 for the failure to maintain documentation supporting payroll expenditures, and \$1,400.00 for a nonpermissible expenditure.

As of November 10, 2009, the date of this report, the Department of Transportation had not determined if the reimbursement of \$255,032.20 would be required.
