Background

The Liquid Fuels Tax Municipal Allocation Law, Title 72 P.S. § 2615.5, provides municipalities other than counties (townships, boroughs, cities, towns, home rule, and optional plan governments) with an annual allocation of liquid fuels taxes from the state's Motor License Fund to be used for the maintenance and repair of streets, roads, and bridges for which the municipality is responsible. The allocation of these funds to municipalities is based: (1) 50 percent on the municipality's proportion of local road mileage to the total local road mileage in the state, and (2) 50 percent on the proportion of a municipality's population to the total population in the state.

The Vehicle Code, Title 75 P.S. § 9511, provides municipalities with annual maintenance payments to be received from the Motor License Fund for functionally local highways that were transferred to a municipality from the Commonwealth of Pennsylvania.

Each municipality must deposit the Liquid Fuels Tax Fund money and annual maintenance payments that it receives into a special fund called the Municipal Liquid Fuels Tax Fund or State Fund. A municipality may not deposit any other monies into this fund except when the municipality does not have enough money in the special fund to meet the payments called for by its current annual budget for road and bridge purposes. In this case, the municipality may borrow money or transfer money from its General Fund to its Liquid Fuels Tax Fund.

The Department of Transportation has been given the regulatory authority for the administration of these funds. To qualify for its annual allocation, each municipality shall submit the following documents and information to the Department of Transportation:

1. Evidence that the treasurer is bonded in accordance with the law, or that its treasurer is a bank requiring no bond by January 31 of each year.
2. A report indicating the manner in which its liquid fuels tax allocation was expended in the previous year (Form MS-965) by January 31 of each year.
3. A report of elected and appointed officials by January 31 of each year.
4. A Survey of Financial Condition by March 15 of each year.

Department of Transportation *Publication 9* contains the policies and procedures that govern the use of Liquid Fuels Tax Fund money. However, if there is a difference between *Publication 9* and any legislation, the legislation shall govern.

Independent Auditor's Report

We examined the accompanying Forms MS-965 With Adjustments for the Liquid Fuels Tax Fund of the Township of Hemlock, Columbia County, for the two years ended December 31, 2010. The municipality's management is responsible for the Forms MS-965. Our responsibility is to express an opinion on the Forms MS-965 With Adjustments based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements contained in *Government Auditing Standards* issued by the Comptroller General of the United States. An examination includes examining, on a test basis, evidence supporting the Township of Hemlock, Columbia County's Forms MS-965 for the two years ended December 31, 2010 and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion.

We are mandated by Section 403 of *The Fiscal Code*, 72 P.S. § 403, to audit each municipality's Liquid Fuels Tax Fund to ensure that funds received are expended in accordance with applicable laws and regulations. *Government Auditing Standards* issued by the Comptroller General of the United States include attestation engagements as a separate type of audit. An attestation engagement performed pursuant to *Government Auditing Standards* involves additional standards that exceed the standards provided by the American Institute of Certified Public Accountants. Accordingly, this attestation engagement complies with both *Government Auditing Standards* and Section 403 of *The Fiscal Code*.

As described in Note 4, the adjustments included on the Forms MS-965 With Adjustments are made by the Department of the Auditor General.

Independent Auditor's Report (Continued)

As discussed in the Finding and Recommendations section of this report, the township expended \$3,500.00 during 2009 and \$6,250.00 during 2010 from the Liquid Fuels Tax Fund for cinders purchased from an uncertified source. Additionally, as discussed in Comment No. 2, during our 2008 examination the municipality expended \$16,810.00 on expenditures related to project No. C07-19210-01 that were not approved to be paid from the Liquid Fuels Tax Fund. This amount was reimbursed to the Liquid Fuels Tax Fund on July 20, 2011, which was subsequent to our examination period.

In our opinion, except for the matters discussed in the preceding paragraph, the Forms MS-965 With Adjustments present, in all material respects, the information required by the Pennsylvania Department of Transportation for the Liquid Fuels Tax Fund of the Township of Hemlock, Columbia County, for the two years ended December 31, 2010, in conformity with the criteria set forth in Note 1.

In accordance with *Government Auditing Standards*, we are required to report findings of significant deficiencies in internal control, violations of provisions of contracts or grant agreements, and abuse that are material to the Forms MS-965 and any fraud and illegal acts that are more than inconsequential that come to our attention during our examination. We are also required to obtain the views of management on those matters. We performed our examination to express an opinion on whether the Forms MS-965 are presented in accordance with the criteria described above and not for the purpose of expressing an opinion on the internal control over reporting on the Forms MS-965 or on compliance and other matters; accordingly, we express no such opinions.

A control deficiency exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect misstatements on a timely basis. A significant deficiency is a control deficiency, or combination of control deficiencies, that adversely affects the Township of Hemlock, Columbia County's ability to initiate, authorize, record, process, or report data reliably in accordance with the applicable criteria such that there is more than a remote likelihood that a misstatement of the Township of Hemlock, Columbia County's Forms MS-965 that is more than inconsequential will not be prevented or detected by the Township of Hemlock, Columbia County's internal control.

Independent Auditor's Report (Continued)

A material weakness is a significant deficiency or combination of significant deficiencies that results in more than a remote likelihood that a material misstatement of the Forms MS-965 will not be prevented or detected by the Township of Hemlock, Columbia County's internal control.

Our consideration of internal control over reporting on the Forms MS-965 was for the limited purpose described in the first paragraph of this section and would not necessarily identify all deficiencies in internal control that might be significant deficiencies or material weaknesses. We did not identify any significant deficiencies or material weaknesses, as defined above, in internal control over reporting on the Forms MS-965.

The results of our tests disclosed the following instance of noncompliance that is required to be reported under *Government Auditing Standards*:

- Purchase Of Cinders Not Approved By Department Of Transportation.

This report is intended solely for the information and use of the Pennsylvania Department of Transportation and the management of the Township of Hemlock, Columbia County, and is not intended to be and should not be used by anyone other than these specified parties.

1. Criteria

Section 1

This section of Form MS-965 With Adjustments provides a summary of Liquid Fuels Tax Fund expenditures by category. Categories requiring explanation include:

- Major equipment purchases are purchases of road machinery and road equipment that cost in excess of \$4,000.00.
- Minor equipment purchases are purchases of road machinery and road equipment that cost \$4,000.00 or less.
- Agility projects are exchanges of services with the Department of Transportation.

Section 2

This section of Form MS-965 With Adjustments provides information on the fund balance. Categories requiring explanation include:

- The state allocation is generally received from the Department of Transportation during the first week in April of each year. The amount the municipality receives is based half on its population and half on its road mileage.
- The turnback allocation is generally received from the Department of Transportation during the first week in April of each year. A municipality receives a yearly turnback allocation based on road mileage for all roads that were transferred to the municipality from the Commonwealth of Pennsylvania through the Highway Transfer Program.
- Expenditures include the total transferred from Section 1.

Section 3

This section of Form MS-965 With Adjustments determines if the municipality expended Liquid Fuels Tax Fund money in excess of the permissible amount for equipment and the balance that the municipality may carry forward for the purchase of equipment to the subsequent year.

Section 3 (Continued)

Department of Transportation *Publication 9* requires that the amount expended for equipment purchases in a given year not exceed the sum of the equipment balance carried forward from the previous year and 20 percent of the current year's Liquid Fuels Tax Fund allocation and, if applicable, 20 percent of the turnback allocation plus other Department of Transportation approved adjustments.

If the municipality spent in excess of the amount listed on Line 4, the excess must be reimbursed to the Liquid Fuels Tax Fund.

The equipment balance to be carried forward for the subsequent year is the lesser of the amount on Line 6 or the ending fund balance on Line 6 of Section 2, but not less than zero.

Basis Of Presentation

The financial activities of the municipality are accounted for in separate funds. The Liquid Fuels Tax Fund is used to account for state aid revenues from the Pennsylvania Department of Transportation used primarily for building and improving local roads and bridges. The Forms MS-965 have been prepared in accordance with reporting requirements prescribed by the Pennsylvania Department of Transportation as a result of the Fuels Tax Act 655, dated 1956 and as amended, which does not constitute a complete presentation of the entity's assets, liabilities, expenses, and fund balance. Accordingly, the presentation of Forms MS-965 With Adjustments is restricted to the Liquid Fuels Tax Fund, which represents a segment of the entity.

Basis Of Accounting

The accompanying Forms MS-965 With Adjustments are prepared in accordance with reporting requirements prescribed by the Pennsylvania Department of Transportation. Under this method, revenues are recognized when received and expenditures are recorded when paid.

General Fixed Assets

General fixed assets are recognized as expenditures at the time of purchase. No depreciation has been provided on the heavy equipment used to maintain and repair roads and bridges.

2. Deposits

The Second Class Township Code, Title 53 P.S. § 68204, authorizes the township to deposit its funds in the following:

- Deposits in savings accounts or time deposits, other than certificates of deposit or share accounts of institutions having their principal place of business in the Commonwealth of Pennsylvania and insured by the Federal Deposit Insurance Corporation (FDIC) or other like insurance. For any amount above the insured maximum, the depository shall pledge approved collateral.
- Certificates of deposit purchased from institutions insured by the FDIC or other like insurance to the extent that such accounts are so insured. For any amounts in excess of the insured maximum, such deposits shall be collateralized by a pledge or assignment of assets. Certificates of deposit may not exceed 20 percent of a bank's total capital surplus or 20 percent of a savings and loan's or savings bank's assets minus liabilities.

Deposits consist of receipts and deposits in a financial institution. Pennsylvania statutes require all deposits to be insured and, for any amount above the insured maximum, to be secured with approved collateral as defined.

There were no deposits exposed to custodial credit risk as of December 31, 2010. Custodial credit risk, as defined by GASB No. 40, includes deposits that are not covered by depository insurance and the deposits are uncollateralized, collateralized with securities held by the pledging financial institution, or collateralized with securities held by the pledging financial institution's trust department or agent but not in the municipality's name.

3. Interest On Investments

Our examination disclosed that the municipality deposited idle liquid fuels tax money in an interest-bearing account which earned \$276.49 during 2009, and \$31.67 during 2010, thus providing additional funds for road maintenance and repairs.

4. Adjustments

2010 - Section 1

Adjustments were made to “Maintenance and repair of roads and bridges,” “Highway construction and rebuilding projects,” and “Miscellaneous” because expenditures of \$35,550.50 were misclassified.

6. Community Development Block Grant Project

On June 8, 2010, the municipality expended \$26,228.42 from its Liquid Fuels Tax Fund for a Community Development Block Grant Project for Fernville Street and sidewalk improvements.

On September 22, 2010, the municipality deposited grant money of \$26,228.42 into its Liquid Fuels Tax Fund that was received from Columbia County for the project.

7. Bank Loan

On September 22, 2005, the municipality borrowed \$66,580.70 from M&T Bank to purchase a 1997 Case International tractor for \$32,000.00 and a new A-Boom hydraulic boom with boom axe and ditcher attachments for \$34,580.70. The term of the loan was for six years at an interest rate of 4.9 percent. Principal and interest payments of \$6,448.15 are due semi-annually. Because the 1997 Case International tractor was restrictively bid, the municipality may only repay the \$34,580.70, plus interest, from the Liquid Fuels Tax Fund for the A-Boom hydraulic boom axe and ditcher attachments. Prior years' principal and interest payments from the Liquid Fuels Tax Fund were \$15,328.89 and \$1,377.19, respectively. Additionally, the municipality paid principal of \$26,964.80 and interest of \$5,018.02 from the General Fund.

During the current examination period, the municipality paid principal of \$24,287.01 and interest of \$1,505.59 from the General Fund. The loan was paid-in-full on July 28, 2010.

8. Lease-Purchase Agreement

On September 11, 2006, the municipality purchased a 2007 Freightliner M2-106 truck for \$87,146.26. The municipality paid a down payment of \$10,073.26 from the General Fund. On November 27, 2006, the municipality entered into a lease-purchase agreement with Columbia County Farmers National Bank for \$33,500.00 for this purchase. Additionally, the municipality borrowed \$43,573.00 from the Department of Community and Economic Development to finance this purchase (Note 9). The agreement was for a term of six years at an interest rate of 4.5 percent. Principal and interest payments of \$3,212.16 are due semi-annually. Prior year's principal and interest payments from the Liquid Fuels Tax Fund were \$10,221.45 and \$2,627.59 respectively.

8. Lease-Purchase Agreement (Continued)

During the current examination period the municipality paid principal of \$2,688.49 and interest of \$523.77 from the Liquid Fuels Tax Fund. These amounts are reflected in major equipment purchases on the 2009 Form MS-965 - Section 1. Additionally, the municipality paid principal of \$8,433.90 and interest of \$1,202.88 from the General Fund. The outstanding balance of the loan as of December 31, 2010 was \$12,156.16, plus interest.

9. Bank Loan

On September 11, 2006, the municipality purchased a 2007 Freightliner M2-106 truck for \$87,146.26. The municipality paid a down payment of \$10,073.26 from the General Fund. The municipality borrowed \$43,573.00 from the Department of Community and Economic Development through their local Government Capital Project Program. Additionally, the municipality borrowed \$33,500.00 from Columbia County Farmers National Bank to finance this purchase (Note 8). The term of the loan was for five years at an interest rate of 2.0 percent. Principal and interest payment of \$2,294.84 are due quarterly. Prior years' principal and interest payments from the Liquid Fuels Tax Fund were \$8,370.42 and \$810.94, respectively. Additionally, the municipality paid principal of \$8,539.09 and interest of \$640.00 from the General Fund.

During the current examination period the municipality paid principal of \$17,597.83 and interest of \$760.89 from the General Fund. The outstanding balance of the loan as of December 31, 2010 was \$9,065.66, plus interest.

10. Bank Loan

During the examination period the municipality expended \$342,773.84 for road project No. 09-19210-01. The municipality expended \$12,773.84 from its General Fund for the project. The municipality borrowed the remaining \$330,000.00 from the Pennsylvania Infrastructure Bank for a term of eight years at an interest rate of 1.625 percent. Principal and interest payments of \$44,323.12 are due annually.

During the current examination period the municipality paid principal of \$38,960.62 and interest of \$5,362.50 from the Liquid Fuels Tax Fund. These amounts are reflected in highway construction and rebuilding projects on the 2010 Form MS-965 - Section 1. The outstanding balance of the loan as of December 31, 2010 was \$291,039.38, plus interest.

Finding - Purchase Of Cinders Not Approved By Department Of Transportation

Our examination disclosed that the municipality expended \$3,500.00 during 2009 and \$6,250.00 during 2010 from the Liquid Fuels Tax Fund for cinders that were not approved by the Department of Transportation. These expenditures are as follows:

The above purchases were not in compliance with the Department of Transportation's *Publication 408*, Section 106.02 (a), which states:

Have the source of material approved before delivery to a project.

The failure to purchase materials as described above that are not approved by the Department of Transportation could result in the municipality having to reimburse \$9,750.00 to its Liquid Fuels Tax Fund.

Recommendations

We recommend that the municipality reimburse \$9,750.00 to its Liquid Fuels Tax Fund upon official notification by the Department of Transportation.

We further recommend that, in the future, the municipality purchase stone that is approved by the Department of Transportation.

Management's Response

The municipal officials offered no formal response at this time.

Comment No. 1 - Summary of 2007 Examination Recommendation

In our 2007 report we recommended that the Department of Transportation review our examination finding to determine if the municipality should reimburse \$7,647.00 to its Liquid Fuels Tax Fund. This amount consists of \$6,447.00 for sidewalk improvements and \$1,200.00 for painting Visual Average Speed Computer and Recorder (VASCAR) lines, which are nonpermissible expenditures.

During our current examination we reviewed a letter dated March 15, 2010, from the Department of Transportation informing the municipality to reimburse \$7,647.00 to its Liquid Fuels Tax Fund. The municipality reimbursed this amount to the Liquid Fuels Tax Fund on April 14, 2010.

Comment No. 2 - Summary Of 2008 Examination Recommendations

In our 2008 report we recommended that the Department of Transportation review our examination finding to determine if the municipality should reimburse \$16,810.00 to its Liquid Fuels Tax Fund for expenditures related to project No. C07-19210-01 that were not approved to be paid from the Liquid Fuels Tax Fund.

During our current examination we reviewed a letter dated July 13, 2011, from the Department of Transportation informing the municipality to reimburse \$16,810.00 to its Liquid Fuels Tax Fund. We noted that the municipality reimbursed this amount to its Liquid Fuels Tax Fund on July 20, 2011, which was subsequent to our examination period.

In our 2008 report we also recommended that liquid fuels tax funds should not be expended for construction projects without the prior approval of the Department of Transportation.

During our current examination we noted that the municipality complied with our recommendation.
