Independent Auditor's Report

The Honorable Leslie Richards Secretary Department of Transportation Harrisburg, PA 17120

We examined the accompanying Form MS-965 With Adjustments for the Liquid Fuels Tax Fund of the Township of Lower Paxton, Dauphin County, for the period January 1, 2016 to December 31, 2016. The municipality's management is responsible for presenting the Form MS-965 in accordance with the criteria set forth in Note 1. Our responsibility is to express an opinion on the Form MS-965 With Adjustments based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and the standards applicable to attestation engagements contained in *Government Auditing Standards* issued by the Comptroller General of the United States. Those standards require that we plan and perform the examination to obtain reasonable assurance about whether the Form MS-965 is in accordance with the criteria described above, in all material respects. An examination involves performing procedures to obtain evidence about the Form MS-965. The nature, timing and extent of the procedures selected depend on our judgement, including an assessment of the risks of material misstatement of the Form MS-965, whether due to fraud or error. We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

We are mandated by Section 403 of *The Fiscal Code*, 72 P.S. § 403, to audit each municipality's Liquid Fuels Tax Fund to ensure that funds received are expended in accordance with applicable laws and regulations. *Government Auditing Standards* issued by the Comptroller General of the United States include attestation engagements as a separate type of audit. An attestation engagement performed pursuant to *Government Auditing Standards* involves additional standards that exceed the standards provided by the American Institute of Certified Public Accountants. Accordingly, this attestation engagement complies with both *Government Auditing Standards* and Section 403 of *The Fiscal Code*.

As described in Note 4, the adjustments included on the Form MS-965 With Adjustments are made by the Department of the Auditor General.

Independent Auditor's Report (Continued)

In our opinion, the Form MS-965 With Adjustments presents, in all material respects, the information required by the Pennsylvania Department of Transportation for the Liquid Fuels Tax Fund of the Township of Lower Paxton, Dauphin County, for the period January 1, 2016 to December 31, 2016, in accordance with the criteria set forth in Note 1.

In accordance with *Government Auditing Standards*, we are required to report all deficiencies that are considered to be significant deficiencies or material weaknesses in internal control; fraud and noncompliance with provisions of laws or regulations that have a material effect on the Form MS-965; and any other instances that warrant the attention of those charged with governance; noncompliance with provisions of contracts or grant agreements, and abuse that has a material effect on the Form MS-965. We are also required to obtain and report the views of responsible officials concerning the findings, conclusions, and recommendations, as well as any planned corrective actions. We performed our examination to express an opinion on whether the Form MS-965 is presented in accordance with the criteria described above and not for the purpose of expressing an opinion on internal control over reporting on the Form MS-965 or on compliance and other matters; accordingly, we express no such opinions.

A *deficiency in internal control* exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A *material weakness* is a deficiency, or combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the Form MS-965 will not be prevented, or detected and corrected, on a timely basis. A *significant deficiency* is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Our consideration of internal control over reporting on the Form MS-965 was for the limited purpose of expressing an opinion on whether the Form MS-965 is presented in accordance with the criteria described above and would not necessarily identify all deficiencies in internal control that might be material weaknesses or significant deficiencies. Given these limitations, during our engagement we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

As part of obtaining reasonable assurance about whether the Form MS-965 is free from material misstatement, we performed tests of the Township of Lower Paxton, Dauphin County's compliance with certain provisions of laws, regulations, contracts, and grant agreements, noncompliance with which could have a direct and material effect on the determination of amounts on the Form MS-965. However, providing an opinion on compliance with those provisions was not an objective of our engagement, and accordingly, we do not express such an opinion. The results of our tests disclosed no instances of noncompliance or other matters that are required to be reported under *Government Auditing Standards*. However, we did note a matter that, while not required to be included in this report by *Government Auditing Standards*, has been included in the finding below:

• Noncompliance With Advertising And Bidding Requirements.

Independent Auditor's Report (Continued)

The purpose of this report is to determine whether the municipality's Liquid Fuels Tax Fund money is spent in accordance with the laws and regulations identified in the Background section of this report and the Department of Transportation's *Publication 9*. This report is not suitable for any other purpose.

TOWNSHIP OF LOWER PAXTON DAUPHIN COUNTY LIQUID FUELS TAX FUND BACKGROUND FOR THE PERIOD JANUARY 1, 2016 TO DECEMBER 31, 2016

Background

The Liquid Fuels Tax Municipal Allocation Law, Act 655 of 1956, as amended, (72 P.S. § 2615.5 et sec.), provides municipalities other than counties (townships, boroughs, cities, towns, home rule, and optional plan governments) with an annual allocation of liquid fuels taxes from the state's Motor License Fund to be used for the maintenance and repair of streets, roads, and bridges for which the municipality is responsible. The allocation of these funds to municipalities is based: (1) 50 percent on the municipality's proportion of local road mileage to the total local road mileage in the state, and (2) 50 percent on the proportion of a municipality's population to the total population in the state.

The Vehicle Code, Title 75 P.S. § 9511, provides municipalities with annual maintenance payments to be received from the Motor License Fund for functionally local highways that were transferred to a municipality from the Commonwealth of Pennsylvania.

Each municipality must deposit the allocation of Liquid Fuels Tax funds and annual maintenance payments that it receives into a special fund called either the Municipal Liquid Fuels Tax Fund or State Fund. A municipality may not deposit any other monies into this fund except when the municipality does not have enough money in the special fund to meet the payments called for by its current annual budget for road and bridge purposes. In such a case, the municipality may borrow money or transfer money from its General Fund to its Liquid Fuels Tax Fund.

The Department of Transportation has been given the regulatory authority for the administration of these funds. Department of Transportation's *Publication 9* includes the policies and procedures for the administration of Act 655, as amended, and the Liquid Fuels Tax Fund money. However, if there is a difference between *Publication 9* and any legislation, the legislation shall govern.

To qualify for the annual allocation of Liquid Fuels Tax funds, *Publication 9* indicates that each municipality shall:

- 1. Submit annual reports (MS-965, Actual Use Report, MS-965P, Project and Miscellaneous Receipts, and MS-965S, Record of Checks).
- 2. Make deposits and payments or expenditures in compliance with Act 655 of 1956, as amended. Failure to do so may result in not receiving allocations from PennDOT until all discrepancies are resolved. *Publication 9*, Section 2.6, includes information about investing Liquid Fuels Tax monies, using loan or bond proceeds, and types of receipts into the Liquid Fuels Tax Fund.

- 3. Submit the Pennsylvania Department of Community and Economic Development's (DCED) Report of Elected and Appointed Officials by January 31st and the Survey of Financial Condition By March 15th.
- 4. Ensure resolution of all Contractor Responsibility Program (CRP) holds and blocks imposed by the Department of Revenue and the Department of Labor and Industry.
- 5. Ensure resolution of all reimbursements required as a result of audits performed by the Department of the Auditor General or monitoring reviews performed by the Department of Transportation's Financial Consultants.

1. <u>Criteria</u>

Section 1

This section of Form MS-965 With Adjustments provides a summary of Liquid Fuels Tax Fund expenditures by category. Categories requiring explanation include:

• Major equipment purchases are purchases of road machinery and road equipment with varying yearly costs in excess of the amounts indicated below:

Section 2

This section of Form MS-965 With Adjustments provides information on the fund balance. Categories requiring explanation include:

- The state allocation is available from the Department of Transportation in March of each year. The amount the municipality receives is based half on its population and half on its road mileage.
- Municipalities that transferred roads from the Commonwealth of Pennsylvania to the municipality through the Highway Transfer Program receive annual turnback allocations in March of each year from the Department of Transportation. Turnback allocations are based on the mileage of the roads transferred.

1. <u>Criteria (Continued)</u>

Section 2 (Continued)

• Expenditures include the total transferred from Section 1.

Section 3

This section of Form MS-965 With Adjustments determines if the municipality expended Liquid Fuels Tax Fund money in excess of the permissible amount for equipment and the balance that the municipality may carry forward for the purchase of equipment to the subsequent year.

Department of Transportation *Publication 9* requires that the amount expended for equipment purchases in a given year not exceed the sum of the equipment balance carried forward from the previous year and 20 percent of the current year's Liquid Fuels Tax Fund allocation and, if applicable, 20 percent of the turnback allocation plus other Department of Transportation approved adjustments.

If the municipality spent in excess of the amount listed on Line 4, the excess must be reimbursed to the Liquid Fuels Tax Fund.

The equipment balance to be carried forward for the subsequent year is the lesser of the amount on Line 6 or the ending fund balance on Line 6 of Section 2, but not less than zero.

Basis Of Presentation

The financial activities of the municipality are accounted for in separate funds. The Liquid Fuels Tax Fund is used to account for state aid revenues from the Pennsylvania Department of Transportation used primarily for building and improving local roads and bridges. The Form MS-965 has been prepared in accordance with reporting requirements prescribed by the Pennsylvania Department of Transportation as a result of the Fuels Tax Act 655, dated 1956 and as amended, which does not constitute a complete presentation of the entity's assets, liabilities, expenses, and fund balance. Accordingly, the presentation of Form MS-965 With Adjustments is restricted to the Liquid Fuels Tax Fund, which represents a segment of the entity.

1. <u>Criteria (Continued)</u>

Basis Of Accounting

The accompanying Form MS-965 With Adjustments is prepared in accordance with reporting requirements prescribed by the Pennsylvania Department of Transportation. Under this method, revenues are recognized when received and expenditures are recorded when paid.

General Fixed Assets

General fixed assets are recognized as expenditures at the time of purchase. No depreciation has been provided on the heavy equipment used to maintain and repair roads and bridges.

2. Deposits

The Second Class Township Code, Title 53 P.S. § 68204, authorizes the township to deposit its funds in the following:

- Deposits in savings accounts or time deposits, other than certificates of deposit or share accounts, of institutions having their principal place of business in the Commonwealth of Pennsylvania and insured by the Federal Deposit Insurance Corporation (FDIC) or other like insurance. For any amount above the insured maximum, the depository shall pledge approved collateral.
- Certificates of deposit purchased from institutions insured by the FDIC or other like insurance to the extent that such accounts are so insured. For any amounts in excess of the insured maximum, such deposits shall be collateralized by a pledge or assignment of assets. Certificates of deposit may not exceed 20 percent of a bank's total capital surplus or 20 percent of a savings and loans or savings bank's assets minus liabilities.

Deposits consist of receipts and deposits in a financial institution. Pennsylvania statutes require all deposits to be insured and, for any amount above the insured maximum, to be secured with approved collateral as defined.

2. <u>Deposits (Continued)</u>

There were no deposits exposed to custodial credit risk as of December 31, 2016. Custodial credit risk, as defined by GASB No. 40, as amended, includes deposits that are not covered by depository insurance and the deposits are uncollateralized, collateralized with securities held by the pledging financial institution, or collateralized with securities held by the pledging financial institution's trust department or agent but not in the municipality's name.

Fund Balance

The fund balance as of December 31, 2016, consists of the following:

3. Interest On Investments

Our examination disclosed that the municipality deposited idle liquid fuels tax money in an interest-bearing account which earned \$204.19 during 2016, thus providing additional funds for road maintenance and repairs.

4. Adjustments

Section 1

Adjustments were made to "Maintenance and repair of roads and bridges" and "Highway construction and rebuilding projects" because expenditures of \$42,822.65 were misclassified.

Section 2

An adjustment of \$4.17 was made to "Miscellaneous" because a deposit in error from the General Fund was not reported (see Note 5).

5. <u>Deposit In Error</u>

On December 31, 2016, the municipality deposited \$4.17 into its Liquid Fuels Tax Fund in error. The municipality transferred this amount from its Liquid Fuels Tax Fund to its General Fund to correct the deposit in error on July 31, 2017, which was subsequent to our examination period.

6. Lease-Purchase Agreement

On March 20, 2014, the municipality entered into a lease-purchase agreement with KS State Bank to purchase a Volvo L90G wheel loader for \$162,610.00. The agreement was for a term of five years at an interest rate of 8.0 percent. Principal and interest payments of \$35,362.80 are due annually. Prior years' principal and interest payments from the Liquid Fuels Tax Fund were \$62,308.67 and \$8,416.93, respectively.

During the current examination period, the municipality paid principal of \$32,496.19 and interest of \$2,866.61 from the Liquid Fuels Tax Fund. These amounts are reflected in major equipment purchases of the 2016 Form MS-965 - Section 1. The outstanding balance of the lease-purchase agreement as of December 31, 2016, was \$67,805.14, plus interest.

7. <u>Lease-Purchase Agreement</u>

On January 13, 2015, the municipality entered into a lease-purchase agreement with Mercedes-Benz Financial Services to purchase a 2015 Freightliner dump truck for \$156,295.00. The agreement was for a term of four years at an interest rate of 6.0 percent. Principal and interest payments of \$41,314.98 are due annually. Prior years' principal payments from the Liquid Fuels Tax Fund were \$41,314.98.

During the current examination period, the municipality paid principal of \$36,888.25 and interest of \$4,426.73 from the Liquid Fuels Tax Fund. These amounts are reflected in major equipment purchases of the 2016 Form MS-965 – Section 1. The outstanding balance of the lease-purchase agreement as of December 31, 2016, was \$78,091.77, plus interest.

8. <u>Lease-Purchase Agreement</u>

On April 15, 2015, the municipality entered into a lease-purchase agreement with KS State Bank to purchase a 2015 TYMCO 600 street sweeper for \$186,537.00. The agreement was for a term of three years at an interest rate of 3.3 percent. Principal and interest payments of \$64,238.74 are due annually. Prior years' principal payments from the Liquid Fuels Tax Fund were \$64,238.74.

During the current examination period, the municipality paid principal of \$60,141.76 and interest of \$4,096.98 from the Liquid Fuels Tax Fund. These amounts are reflected in major equipment purchases of the 2016 Form MS-965 – Section 1. The outstanding balance of the lease-purchase agreement as of December 31, 2016, was \$62,156.50, plus interest.

Finding - Noncompliance With Advertising And Bidding Requirements

Our examination disclosed that the township expended \$43,272.53 during 2016 from the Liquid Fuels Tax Fund for the maintenance and repair of traffic signals without advertising for bids.

The above expenditures were not made in compliance with the advertising, bidding, and contract requirements of *The Second Class Township Code*, 53 P.S. § 68102(a), (also found at § 3102(a) of *The Second Class Township Code* as published by the Local Government Commission), which requires that purchases over \$18,500.00 during 2012 must be advertised, bid, and awarded by contract. The bidding threshold increased to purchases over \$18,900.00 for 2013, \$19,100.00 for 2014, \$19,400.00 for 2015 and 2016, \$19,700 for 2017, and \$20,100.00 for 2018. *The Second Class Township Code*, 53 P.S. § 68104(a), (also found at § 3104(a) of *The Second Class Township Code*, 53 P.S. § 68104(a), further states that advertising, bidding and contract requirements should not be evaded through piecemeal purchases.

The failure to comply with *The Second Class Township Code* could result in the township having to reimburse \$43,272.53 to its Liquid Fuels Tax Fund.

Recommendations

We recommend that the township reimburse \$43,272.53 to its Liquid Fuels Tax Fund upon official notification by the Department of Transportation.

We further recommend that, in the future, the township complies with *The Second Class Township Code* as noted in this finding.

Management's Response

The township solicitor stated:

The Township has advised me that there was an audit finding made in the audit, which stated as follows: "Finding - Noncompliance With Advertising And Bidding Requirements", despite the fact that *The Second Class Township Code* provides in Section 3102(h)(1), 53 P.S. §68102(h)(1), as follows: "The contracts or purchases made by the board of supervisors involving payments in excess of the required advertising amount which do not require advertising, bidding or price quotations are as follows: (1) Those made for emergency, or routine maintenance, repairs or replacements for water, electric light and other public works of the township if they do not constitute new additions, extensions or enlargements of existing facilities and equipment."

Management's Response (Continued)

It is my understanding that legal counsel from the Pennsylvania Department of Transportation ("PADOT") determined that roads and bridges are not exempt under Section 3102(h)(1), but there has been no explanation of the legal basis for such a conclusion. While the term "public works" is not defined, in the case *Heiges Masonry v. Adams County*, 24 Pa. D & C. 315 (Pa. Com. Pl. 1981), the court in interpreting Section1802 (h)(1) of the County Code, which is the same language found in Section 3102(h)(1) determined that since the term "public works" is undefined in the County Code, a general everyday definition should be used. The court adopted the following definition: "all works constructed for public use, protection or enjoyment ordinarily of a fixed nature." Similarly, both the Steel Products Procurements Act, 73 P.S. § 1886 and the Trade Practices Act, 71 P.S. § 773.102 define "public works" to include any structure, building, highway, street, bridge, etc. Therefore, highway, street, bridges and traffic signals are considered "public works" as set forth in Section 3102(h)(1) of *The Second Class Township Code*, which authorizes maintenance thereof without advertising, bidding or price quotations.

In addition, neither the Liquid Fuels nor Fuels Tax Act, 75Pa.C.S. §9001 et seq., nor the Liquid Fuels Tax Municipal Allocation Law, 72 P.S. §2615.1 et seq., define "public works" nor state that maintenance of highways, bridges and traffic signals must be bid in order to qualify for Liquid Fuels expenditures. Moreover, in the regulations promulgated under the Liquid Fuels Tax Municipal Allocation Act at 67 Pa. Code §449.1 et seq. likewise do not define "public works" nor do they state that maintenance of highways, bridges and traffic signals must be bid in order to qualify for Liquid Fuels expenditures. Interestingly, 67 Pa. Code §449.3(a) states that advertising, bidding and a performance bond are required by statute and then proceeds to list citations to the contracting provisions of all of the municipal enabling statues, including The Second Class Township Code, the First Class Township Code, the Borough Code, among others, although the citations are outdated with regard to the section numbers. For example, the citation to the contracting sections of The Second Class Township Code is set forth as 53 P.S. §§65801-65809, which now are 53 P.S. §§68101-68109. In listing the citations for the contracting provisions in each of the municipal enabling statues. Section 449.3 of the regulations is indicating that the municipal codes dictate the rules for contracting and not the Liquid Fuels statues or PADOT. In addition, the requirements for municipal bidding have dramatically changed since the regulations were promulgated.

Accordingly, the Township demands that the above-referenced audit finding be removed because it is without any legal basis.

Auditor's Conclusion

The Department of Transportation has been statutorily authorized to promulgate regulations concerning the administration of Liquid Fuels Tax Fund money. The Department of Transportation has informed us that the maintenance and repair of traffic signals is required to be bid if the amount expended in a given year is over the bidding threshold. The township may appeal this finding to the Department of Transportation. The Department of Transportation will determine if the municipality will be required to reimburse \$43,272.53 to its Liquid Fuels Tax Fund. During our next examination we will determine if the municipality complied with our recommendations.
