

Dear Governor Wolf and Mr. Butchy:

We conducted a Limited Procedures Engagement (LPE) of the Mercer Area School District (District) to determine its compliance with certain relevant state laws, regulations, policies, and administrative procedures (relevant requirements). The LPE covers the period February 4, 2014 through April 30, 2015, except for any areas of compliance that may have required an alternative to this period. The engagement was conducted pursuant to authority derived from Article VIII, Section 10 of the Constitution of the Commonwealth of Pennsylvania and the Fiscal Code 72 P.S. § 403, but was not conducted in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States.

As we conducted our LPE procedures, we sought to determine answers to the following questions, which serve as our LPE objectives:

- Does the District have documented board policies and administrative procedures related to the following?
 - o Internal controls
 - o Budgeting practices
 - o The Right-to-Know Law
 - The Sunshine Law
- Are the policies and procedures adequate and appropriate, and have they been properly implemented?
- Did the District comply with the relevant requirements in the Right-to-Know Law and the Sunshine Law?
- Did the District take appropriate corrective action to address the findings, observations, and verbal comments made in our prior audit, and were the actions taken into effect?

Status of Prior Findings and Observations

Finding

Certification Deficiency

Finding Condition

Our prior audit of the District's professional employees' certification for the period February 22, 2012 through November 6, 2013, found that one individual, a certified Principal K-12, was assigned to the position of Coordinator of Special Education without possessing the proper certification during the 2012-13 and 2013-14 school years.

On December 5, 2013, the Pennsylvania Department of Education's (PDE) Bureau of School Leadership and Teacher Quality (BSLTQ) confirmed the employee was not properly certified for the 2012-13 school year and for one month during the 2013-14 school year. The District was, therefore, subject to subsidy forfeitures of \$1,096 for the 2012-13 school year and \$96 for the 2013-14 school year.

Recommendation

Our audit recommended the District should:

In conjunction with BSLTQ's determination, require District administrative personnel to ensure that an individual's certification meets the requirement of the assignments that the District intends to assign the individual.

Our audit recommended that PDE should:

Adjust the District's allocations to recover the appropriate subsidy forfeitures.

Current Status

Effective August 1, 2013, PDE approved a certified Principal K-12 to serve as a single area supervisor. Therefore, the Principal K-12 certification that the Coordinator of Special Education holds is currently appropriate.

As of April 30, 2015, the subsidy forfeitures for the certification deficiency had not yet been recovered by PDE.
