

Dear Ms. Jez and Mr. Proper:

We conducted a Limited Procedures Engagement (LPE) of the Titusville Area School District (District) to determine its compliance with certain relevant state laws, regulations, policies, and administrative procedures (relevant requirements). The LPE covers the period August 30, 2013 through August 13, 2015, except for any areas of compliance that may have required an alternative to this period. The engagement was conducted pursuant to authority derived from Article VIII, Section 10 of the Constitution of the Commonwealth of Pennsylvania and The Fiscal Code 72 P.S. § 403, but was not conducted in accordance with *Government Auditing Standards* issued by the Comptroller General of the United States.

As we conducted our LPE procedures, we sought to determine answers to the following questions, which serve as our LPE objectives:

- Did the District have documented board policies and administrative procedures related to the following?
 - Internal controls
 - o Budgeting practices
 - o The Right-to-Know Law
 - o The Sunshine Law
- Were the policies and procedures adequate and appropriate, and have they been properly implemented?
- Did the District comply with the relevant requirements in the Right-to-Know Law and the Sunshine Law?
- Did the District take appropriate corrective action to address the finding made in our prior audit, and were the actions taken into effect?

Status of Prior Findings and Observations

Finding:

Board Action Violated the Public School Code and Board Policy

Prior Finding Condition

The District did not seek competitive bids for the construction of its middle school ropes course, nor did the District secure approval from the Pennsylvania Department of Education, as required by the Public School Code (PSC), at the time of the construction of the course.

Prior

Recommendations

Our prior audit recommended that the District should:

- 1. Require administrators to follow the PSC bidding requirements and the District's bidding policies when making purchases for the District.
- 2. Adhere to the provisions and restrictions of the PSC in all future projects, as applicable.

Current Status

We found that the District implemented our prior audit recommendations. The District's current contracting and bidding requirements were reviewed and found to be in compliance with the PSC and board policy.
